I agree to exercise due and reasonable care in the feeding and housing of the above pet. All pets are boarded or otherwise handled by me or my staff without liability on my part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets or property by said pet, or other unavoidable causes, due diligence and care having been exercised. The pet owner is responsible for any property damage done by his/her pet.

If the pet should become seriously ill, the owner shall be notified at once. I shall have the right to call a veterinarian designated by the owner, or if none is designated, to call a veterinarian of my selection in the event of need for quick action, or to administer medicine or to give other desirable attention within my discretion and judgment. Such expense(s) being reasonable in amount shall be paid promptly by the owner of the pet.

The owner certifies that he is the legal owner of the pet and that said pet has had shots for all diseases including distemper, infectious hepatitis and leptosporosis, parvo, rabies and bordetella for a dog and distemper, rabies and leukemia for a cat, within the last year, and that said pet has not been exposed to these diseases within the last thirty days. He also certifies that the required annual pet license has been obtained, and that all fees will be paid before the pet is released to owner.

CREDIT CARDS, CASH AND CHECKS ARE ACCEPTED. RETURNED CHECKS SUBJECT TO \$35 FEE. PETS PICKED UP AFTER 12 NOON WILL BE CHARGED FOR THE DAY. FULL DAY'S FEES WILL BE CHARGED ON SUNDAYS AND HOLIDAYS. 24 HOURS ADVANCE NOTICE REQUIRED FOR EARLY PICK-UP. NO CHANGES IN RESERVATIONS ON HOLIDAYS AND DURING JULY AND AUGUST.
